
infrastructure. It is a member in the family of the 22 National Law Universities established across the country.

# ABOUT NIOS, MINISTRY OF EDUCATION, GOVERNMENT OF INDIA

The National Institute of Open Schooling (NIOS) envisages schooling by providing a learning continuum based on graded curriculum ensuring quality of education for children, Neoliterates, school drop-outs/left-outs and NFE completers. It operates through a network of five Departments, 23 Regional Centres, two Sub Regional Centres, two NIOS Cells, and more than 7400 Study Centres (AIs/AVIs) spread all over the country and abroad. NIOS is the largest Open Schooling system in the world with cumulative enrolment of 4.13 million (during last 5 years).

#### **Concept Note:**

Massive open online courses (MOOCs) are gaining momentum all across the world in the recent times ensuring access to quality education over web. India is also witnessing a surge in interest in MOOCs owing to its cost effectiveness and its wide reach. It also ensures to enhance the quality of education offering the flexibility of time and access. MOOCs have a lot to offer. They are beneficial not only to the student community but also all the stakeholders. It is available in a variety of disciplines.

With the rapid development in the information and communication technologies, MOOCs have become easily accessible. The prominent platforms for MOOCs in India include NPTEL, mooKIT, edx, Coursera and Swayam. Swayam is a programme initiated by Government of India under the Ministry of Education for achieving the three Cardinal principles of education policy that is Access, Equity and Quality. Aimed at providing the best teaching learning resources to all, including the most disadvantaged. It is a platform for providing education from class nine to post graduation.

For ensuring that the best quality content is produced and delivered, 9 National coordinators have been appointed. Apart from MOOCs, there are multiple other platforms developed by Government of India for ensuring e-learning like Diksha for courses of NCERT, CBSE and SCERTS across India; e-Shodh Sindhu for accessing peer-reviewed journals; e-PG Pathshala for e-content in disciplines of Social

Sciences, arts, fine arts, Humanities, natural and mathematical Sciences; Swayam Prabha for telecasting high quality educational programs; and NPTEL for providing access to open online courses around engineering and core science subject.

Considering the importance of MOOCs, this Faculty Development Program aims to be a forum for the stakeholders to discuss and deliberate on potential of MOOCs and its optimum utilisation in the field of education policy. It will witness engaging sessions from various experts in stakeholders not only for sensitization but also for its effective implementation. "Uninterrupted Education, Anytime Anywhere", should be the motto of our education policy.

The Faculty Development Program will be one week programme (seven days) from **October 18, 2021** to **October 24, 2021** in the afternoon (2 p.m. to 5 p.m.).
